#### **VISA Letter of Invitation Information**

**International exhibitors:** Information and resources about obtaining visas is available online at <a href="http://www.ofcconference.org/home/register-and-plan-travel/letter-of-invitation/">http://www.ofcconference.org/home/register-and-plan-travel/letter-of-invitation/</a>

If you are bringing individuals from countries that need visas to enter the United States, we urge you to apply as soon as possible. In most instances the visa is being acted on within 30 days or less, but checks may take longer depending on country and application information. You may visit <a href="http://travel.state.gov/visa/visa\_1750.html">http://travel.state.gov/visa/visa\_1750.html</a> to download visa forms, view fees and read more information about the process.

In order to assist exhibitors, OFC Management will be providing a separate letter of support that may help exhibit personnel in obtaining a visa. This letter will confirm that the exhibitor has signed a contract to exhibit at the conference and will note, if applicable, if the company has exhibited at OFC previously. Unfortunately, OFC Management cannot guarantee visas for any exhibitor or its personnel.
